Noorul Islam Centre for Higher Education (NICHE), India & Noorul Islam Institute of Medical Science and Research Foundation (NIMS), India, and The National University of Sudan establish this Letter of Intent to foster International cooperation in Education, Research and Healthcare services. This Interim agreement summarizes the main points of a proposed deal, confirming that a certain course of action is going to be taken by both parties. It also indicates a genuine interest in

reaching the final agreement on the modalities of cooperation case by case, and this of course is subject to due diligence, additional information and fulfilment of certain conditions by both parties within the framework of mutually beneficial win-win situation.

MAIN ACTIVITIES

- A. To offer B.E course in Biomedical Engineering for the students from the National University of Sudan.
- B. To offer B.Sc course In Human Genetics and Molecular Biology(Under the Department of Biomedical Science and Technology) for the students from the National University of Sudan.
- C. To offer B.Tech course in Nanotechnology for the students from the National University of Sudan.
- D. Establishment of a training and technology transfer centre for Advanced Human Genetics Laboratory in Sudan, to be affiliated to the National University of Sudan.

SCOPE

Curriculum exchange and sharing of academic and technical expertise for establishing full-fledged Departments in the field of Higher education with emphasis on B E Biomedical Engineering, B Tech Nanotechnology and B Sc Human Genetics and Molecular Biology (Under the Department of Biomedical Science and Technology).

Both parties will encourage the following activities to promote international academic and healthcare service cooperation:

- a) Cooperation in the exchange of information relating to their activities in teaching and research in fields of:
 - i. Human Genetics and Molecular Biology
 - ii. Nanotechnology
- b) Training and technology transfer in establishing Human Genetics Laboratory.
- c) Promoting appropriate joint research projects and joint courses of study,
- d) Joint organization of seminars, conferences and workshops on topics of mutual interest, and extending invitation to each other's faculty to participate therein.
- e) Endeavour to encourage students and staff to spend substantial period of time in the host University.
- f) Facilitating the exchange of students.

g) Training the members of staff and other personnel for academics as well as protocols in Human genetics by the host University.


Before implementing these activities, the parties shall have elaborate discussions on the Opportunities and challenges presented and may thereafter enter into specific agreements based on the mutually agreed objectives and outcomes.

This Letter of Intent forms the framework for cooperation between the parties to identify and achieve the shared goals and objectives and also to facilitate and develop a genuine and mutually beneficial exchange process and research relationship.

This Letter of Intent is non-binding and does not impose any legal or financial obligations or liabilities on either party.

This Letter of intent shall remain in effect for five years, unless either party terminates sooner by notifying the other party in writing, or the joint activities contemplated by this Letter of Intent are completed before the end of the five-year period.

The parties may extend this Letter of Intent beyond five years by mutual agreement.


