ON FREINDSHIP AND COORPORATION, PROMOTION OF MUTUAL UNDERSTANDING, ACADEMIC, CULTURAL AND SCIENTIFIC THOUGHT AND STUDENT, PERSONNEL EXCHANGE

This Memorandum of Understanding (hereinafter referred as "MOU" is executed between NATIONAL UNIVERSITY - SUDAN (hereinafter referred to as "NUSU" is a private higher education institution, established in 2005 as the " National College for Medical and Technical Studies" upgraded to "University " in October 2013. It is located in the Sudan Capital Khartoum, AND

NOVODUX ACADEMY (hereinafter referred to as 'NOVODEUX) is a private academic institute, Founded in 2016. It is located in Egypt Capital Cairo. The NOVODUX ACADEMY is established for dental training. (hereinafter to as singularly as" the party" and collectively as" Parties") WHEREAS

- A. NUSU is the first and only ISO- certified higher education institution in Sudan, in areas of quality management of academic programmes of Medicine, Pharmacy, Dentistry, Physiotherapy, Radiographic sciences and medical imaging, health informatics, Nursing, Business administration, Engineering, International relation and diplomatic studies, computer sciences and medical laboratories. The graduates of NUSU are recognized in USA, UK, and Europe and Gulf Countries.
- B. The NOVODUX ACADEMY in EGYPT is a leading training academy in Egypt and Middle East that is recognized by American Dental Association and Royal College of Surgeons of Edinburgh.

<u>ARTICLE 1</u>

OBJECTIVE

1. The parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulation and national policies from time to time in force in each party's country, shall endeavor to strengthen, promote and develop training excellence between the parties based on equality and mutual benefit.

ARTICLE 2

AREAS OF COORPORATION

- 2.1 Both parties agree to encourage the following activities, in particular, to promote international academic cooperation in the following areas:
 - i. Promotion of institutional exchanges between faculty, staff from each partner institution.
 - ii. Organization of Symposia, conferences, short courses on clinical training and competence
 - iii. Organization of Symposia, conferences, short courses and meeting on research issues;

- v. Medical collaboration
 - a) Exchange of medical teaching staff.
 - b) Secondment of dental professional (short and long terms).
 - c) Involve students with medical examiners
 - d) Research collaboration
- vi. Training staff and promotion through especially designed courses in collaboration with CPD or through nomination of the faculty for discount in all course held by the institute during the period of this MoU.
- vii. Information and communication technology (ICT)
 - a) Website improvement
 - b) Paperless exams
- viii. Standardization and accreditation by external bodies
 - A. Novodeux will benefit from the experience of NUSU in the process of institutional accreditation of the British Accreditation Council (BAC).
 - B. NUSU/ Faculty of Dental Medicine and Surgery will benefit from the experience of NOVODEUX Academy Egypt in Collaboration with international dental bodies such as RCSEDINBURG.
- 2.2 For the purpose of implementing the co-operation in respect of any areas stated in paragraph 2.1 the parties shall enter into legally binding agreement subject to terms and conditions as mutually agreed upon by the patties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of disputes".

ARTICLE 3

FINANCIAL ARRANGEMENTS

- 3.1 Details of this agreement will be found in the legal contract
- 3.2 Novodeux shall avail the premises for training of students as per agreement
- 3.3 Each party shall take its part for the implementation of this Memorandum of Understanding.

ARTICLE 4

EFFECT OF MEMORANDUM OF UNDERSTANDING

- 4.1 This Memorandum of Understanding serves only as record of the parties' intentions. It does not constitute or create obligations under domestic or international law. MOU shall not give rise to any legal process and shall not be deemed to constitute or create any legally binding or enforceable obligations, express or implied
- 4.2 A legal contract shall be signed by both parties to indicate the legal conditions

ARTICLE 5

5. Nothing contained herein is to be construed to constitute a joint venture partnership or formal business organization of any kind between the parties or so to constitute either party as agent of the other.

ARTICLE 6

ENTRY INTO EFFECT AND DURATION

- 6.1 This Memorandum of Understanding shall become effective as of the date of signatures of both parties, or if the dates vary, then the date of the later signature.
- 6.2 This Memorandum of Understanding shall remain in effect for a period of one year
- 6.3 This Memorandum of Understanding may be extended for such further period as may be agreed in writing by both parties.
- 6.4If this Memorandum of Understanding is not renewed by mutual consent, Memorandum of Understanding shall conclude at the end of the specified period, or after activities in progress have concluded.

ARTICLE 7

REVISIONN, VARIATION AND AMENDMENT

- 7.1 Either party may request in writing a revision or amendment of this Memorandum of Understanding.
- 7.2 Any such revision, or amendment agreed to by the parties shall be in writing and shall form part of this Memorandum of Understanding shall.
- 7.3 Such revision, variation or amendment shall come into force on such date as may be determined by the parties.

Any revision, variation or amendment shall not prejudice the implementation of any project, activity or co-operation arising from or based on this Memorandum of Understanding shall before or up to the date of such revision, variation or amendment.

ARTICLE 8

TERMINATION

8. Either party with a minimum of Thirty days (30) written notice may terminate this Memorandum of Understanding. Activities in progress at the time of termination of this Memorandum of Understanding shall be permitted to conclude as planned unless otherwise agreed.

ARTICLE 9

IMPLEMENTATION MECHANISM

9.1 The two Parties agreed to constitute a working committee THREE (3) member for each party for coordination, collaboration and implementation of the Memorandum of
