



## **Agreement for Academic and Scientific Collaboration Between**

**The National University (Sudan)**

**AND**

**The Mycetoma Research Center, University of Khartoum (Sudan)**

For the first part, Prof **Qurashi Mohamed Ali**, The National University Vice Chancellor (hereinafter NU) and of the second part, **Prof Ahmed Hassan Fahal**, The Mycetoma Research Center, University of Khartoum (hereinafter MRC - U of K).

Both parties acknowledge their mutual and sufficient legal capacity to enter into this Framework Agreement, and to this effect,

### **AGREE**

#### **I**

#### **Aims of the UN**

- I. The National University, Sudan, in 2005 the university was established and it is reconized globally in education, research and community development.

#### **II**

#### **Aims of the MRC-UofK**

- II. The MRC-U of K, In 1991, The Mycetoma Research Centre (MRC) was established under the umbrella of the University of Khartoum. It was set up at Soba University Hospital. The centre is recognised globally as a world leader and an authoritative

advisor in mycetoma management and research. It is a WHO Collaborating Centre on Mycetoma and Skin NTDs.

### **Statement of intentions**

- III. Both entities, considering that they have matching and complementary goals, wish to sign this Agreement to enhance their respective tasks, which formalises this document under the following:

### **CLAUSES**

#### **Clause 1.**

Both institutions agree to promote joint academic and scientific cultural endeavours and foster cooperation between them in the fields of research, community development, teaching and training.

#### **Clause 2.**

Both institutions agree to cooperate in all areas of mutual interest and research programs.

#### **Clause 3.**

Within this framework, both institutions shall cooperate in the following activities:

1. Joint research, community development activities and training activities in areas of mutual interest to both;
2. Exchange of information in areas of mutual interest to both;

#### **Clause 4.**

Every joint project concerning this Agreement will be developed and put into practice by means of an Appendix in which all the details about the particular activity will be specified.

#### **Clause 5.**

A handwritten signature in black ink, appearing to be "Fahal", located at the bottom right of the page.

The disagreements and contentious issues about the interpretation, modification, termination and effects that may arise from the application of this convention shall be settled amicably by mutual Agreement between the parties.

### **Clause 6.**

This Convention shall enter into force on the day of the last signature and once it has been approved by the competent authorities and will last for four years.

### **Clause 7.**

The modification or termination of this Agreement may be requested, in writing, with a minimum of three months, by either party, subject to pre-established activities and resolved based on mutual Agreement.

The present Agreement is signed in three copies, each equally valid version.
